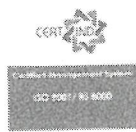

The company monitors the evolution of the situation caused by COVID - 19 and is prepared to impose additional measures if the situation so requires.

Considering that the Annual General Meeting of Shareholders has been convened to take place on 07.04.2020 if requested, the Company will respect the right of shareholders to obtain the informative materials by correspondence or e-mail instead of presenting physically at the headquarters of the Company.
